WAIVER

I, the undersigned, in consideration of the services of Back into the Wild, its officers, agents, employees, or representatives, hereby agree to release and discharge Back into the Wild, on behalf of myself, my heirs, assigns, personal representatives and estate as follows

1. I fully understand and acknowledge that the activities, including hiking, snowshoeing and transportation, that I am about to voluntarily engage in as a participant and/or volunteer bear certain known risks and unanticipated risks which could result in injury, death, illness, disease, physical or mental damages, or damage to myself, my property, or to spectators, or other third parties. The following describes some, but not all of those risks.
 - The Nature of the activity itself has inherent particular risks;-the acts of omissions, negligence in any degree of Back into the Wild, its agents or employees, and other persons or entities, - latent or apparent defects in equipment or property supplied by Back into the Wild, or other person or entities, - acts of other participants in this activity, employees and agents of Back into the Wild, or other person or entities.-my own physical condition of my own acts of omissions, -condition of roads, trails, waterways, fields or terrain and accidents connected with their use, first aid emergency treatment or other services rendered,- consumption of food or drink, hypothermia, contact with domestic and wild animals, separated from the group, high altitude, severe weather changes, collisions with other animals or objects, injury from falling and the potential of a participant to act in a negligent manner that contributes to injury to the participant or others.

I understand and acknowledge that the above list is not exhaustive, and that other risks, known or unknown, identified or unidentified, anticipated or unanticipated may result in injury, death, illness, or disease, or damage to myself, to my property or to participants. I knowingly and expressly accept those not specifically listed above as well.

2. I am fully aware that the activities entail known and unknown risks of injury to myself and a risk of injury to spectators or other third parties as a result of my own actions. I fully understand and acknowledge that Back into the Wild cannot guarantee my safety. Being fully aware of the foregoing, I expressly agree, promise and covenant to accept and assume all risks, responsibility and risk for injury, death, illness, of disease, or damage to myself, to others, or to my property arising from my participation in this activity. My participation is purely voluntary, no one is forcing me to participate and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify Back into the Wild, its agents or employees and all other persons or entities from any and all liability, claims, demands, actions or rights of action, which are related to, arise out of or are in any way connected with my participation in this activity, including specifically but not limited to the negligent acts or omissions of Back into the Wild, its agents or employees, and all other persons or entities, for any and all injury, death, illness, or disease, and damage to myself or to my property. **IN SIGNING THIS DOCUMENT, I FULLY RECOGNIZE THAT IF ANYONE IS HURT OR PROPERTY IS DAMMAGED WIHILE I AM ENGAGED IN THIS ACTIVITY, I WILL HAVE NO RIGHT TO MAKE A CLAIM OR FILE A LAWSUIT AGAINST BACK INTO THE WILD, ITS AGENTS OR EMPLOYEES AND ALL OTHER PERSONS OR ENTITIES EVEN IF THEY OR ANY OF THEM NEGLIGENTLY CAUSED THE BODILY INJURY OR PROPERTY DAMAGGE.**
4. Should it become necessary for Back into the Wild, or someone on Back into the Wilds behalf, to incur attorneys' fees and costs to enforce this agreement, or any portion thereof, I agree to pay Back into the Wild reasonable costs and attorneys' fees thereby expended, or for which liability is incurred.
5. I certify that I have sufficient health, accident, and liability insurance to cover any bodily injury or property damage I may incur while participating in these activities and to cover bodily injury or property damage caused to a third party as a result of my participation in this event. If I have no such insurance, I certify that I am capable of personally paying for any all such expenses or liability.
